18 hereby repealed and reenacted, with amendments, to read as follows:

23 **§ 101-1. Plat, permit and inspection fees.**

24 The schedule of fees for issuance of the specified permits, as listed in this section, shall be as

28 **review fees:** Fee schedule developed by the Charles Soil Conservation District (((SCS))) (SCD) and  
29 endorsed by the ((Mayor and)) Council OF THE TOWN OF LA PLATA; all fees collected by  
30 (((SCS)) SCD.
