1 A RESOLUTION concerning

3 **Agreement with EnerNOC, Inc.**

5 **FOR** the purpose of authorizing the Town Manager to execute and deliver, on behalf of the  
6 Town of La Plata, an agreement with and to EnerNOC, Inc. for participation in their  
7 electricity demand load shedding programs.

11 **WHEREAS**, there are times when energy demands threaten to exceed the capacity of the  
12 electrical grid and cause it to fail; and

13  
14 **WHEREAS**, there are programs that allow for customers that consume large amounts of  
15 electricity to receive payments in exchange for curtailing their use of power in periods of  
16 extremely high demand; and

17  
18 **WHEREAS**, the Town has five facilities that consume enough power to qualify for  
19 participation in one of these programs; and

21 **WHEREAS**, the Town has determined that it has the ability to maintain operations and  
22 services at these five facilities using back-up generators in lieu of power from the power grids for  
23 periods of up to four hours at a time; and

25 **WHEREAS**, the Town is always seeking new revenue sources; and



27 **WHEREAS**, the Town has a responsibility to act in a civically responsive manner.

29 **NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE TOWN**  
30 **OF LA PLATA** that Daniel J. Mears, the Town Manager, is hereby authorized to execute and  
31 deliver, on behalf of the Town of La Plata, an agreement with and to EnerNOC, Inc.,  
32 substantially in the form attached to this Resolution, for participation in their electricity demand  
33 load shedding programs, contingent upon the Town attorney's review and approval of the  
34 contract documents.
