3 **Contract for Willow Lane Stimulus Project Engineering Work**

5 **FOR** the purpose of hiring a firm to serve as the Town of La Plata's (the "Town") engineer and
6 construction manager on the Willow Lane Pump Station and Force Main project.

10 **WHEREAS**, the project is primarily being funded with Federal stimulus dollars that are being
11 administered by the Maryland Department of the Environment (MDE); and

13 **WHEREAS**, there are stringent timelines that the project must meet to qualify for the Federal
14 stimulus funds; and

16 **WHEREAS**, there is a need to promptly modify the construction documents, drawings and
17 specifications for the project so that they comply with the Federal stimulus and MDE requirements; and

18
19 **WHEREAS**, the Town needs someone to serve as construction manager for the project; and

20
21 **WHEREAS**, McCrone, Inc. is recognized as professionally competent engineering firm and
22 was the firm that prepared the bulk of the project drawings and thus has extensive knowledge about the
23 project; and

25 **WHEREAS**, the Town therefore feels McCrone would be the most qualified and able to
26 perform the required tasks in the limited amount of time available at the most reasonable cost, the
27 Town is requesting that the Town Council authorize the Town Manager to enter into a contract with
28 McCrone, Inc. for the services outlined above and allow for the final details of the contract to be
29 negotiated with McCrone by the Town Manager; and

31 **NOW, THEREFORE, BE IT RESOLVED** by the Council of the Town of La Plata that, as

32 evidenced by this Resolution, the Town intends to enlist the services of McCrone, Inc. to serve as the

34 Town's engineer for the Willow Lane Pump Station and Sanitary Sewer stimulus project for an amount
35 not to exceed \$250,000.
