1 **An Ordinance** concerning

3 **Town of La Plata FY2005-2006 Tax Rate**

4  
5 **FOR** the purpose of adopting the Town of La Plata FY2005-2006 Tax Rate; and all matters  
6 generally relating thereto.

7  
8 **SECTION 1: BE IT ENACTED BY THE COUNCIL OF THE TOWN OF LA PLATA**

9 That the Town of La Plata tax rate on real property having location within the corporate limits of the  
10 Town of La Plata, except as provided by State law, for the fiscal year 2005-2006 shall be at the rate  
11 of thirty-two cents (\$.32) per one hundred dollars (\$100.00) of assessed valuation for the fiscal year  
12 2005-2006, with billing for taxes on new property to conform to the method currently in place with  
13 the Charles County Treasurer's Office; and the personal property and public utilities tax rate for the  
14 fiscal year 2005-2006 shall be at the rate of seventy-five cents (\$.75) per one hundred dollars  
15 (\$100.00) of assessed valuation.

17 **SECTION 2: AND BE IT FURTHER ENACTED** that this Ordinance shall become  
18 effective on 1 July 2005.
