**An Emergency Ordinance** concerning

**Amendment to Town of La Plata FY2011-2012 Financial Plan/Budget**

**FOR** the purpose of amending the Town of La Plata FY2011-2012 Financial Plan/Budget; and all matters generally relating thereto.

**WHEREAS**, it is the intention of the Council of the Town of La Plata, by this emergency ordinance to allocate the FY2011-2012 appropriations to appropriate deposit funds and related expenditures as part of a certain Petition for Annexation; and

**WHEREAS**, it is the intention of the Council of the Town of La Plata, by this emergency ordinance to appropriate and authorize the expenditure of funds on goods and services acquired or rendered in association with the Johel Annexation during FY2011-2012 and the reimbursement thereof by the applicant/petitioner.

**SECTION 1: BE IT ENACTED BY THE COUNCIL OF THE TOWN OF LA PLATA** that the Town of La Plata FY2011-2012 Financial Plan/Budget be amended as attached hereto as Attachment 1.

**SECTION 2: AND BE IT FURTHER ENACTED BY THE COUNCIL OF THE TOWN OF LA PLATA** that, at least a majority of the entire Council having determined that an emergency exists, this Ordinance shall become effective on August 28, 2012.
