9 **LA PLATA** THAT the Town of La Plata FY2012-2013 Financial Plan/Budget be amended, as  
10 attached hereto as Attachment 1, to appropriate \$100,000.00 in Community Parks and  
11 Playground Grant funding being provided by the Department of Natural Resources, for the  
12 purpose of using the awarded funds for construction of the Tilghman Lake Parking Lot.

14 **SECTION 2: AND BE IT FURTHER ENACTED BY THE COUNCIL OF THE**  
15 **TOWN OF LA PLATA** that, at least a majority of the entire Council having determined that an  
16 emergency exists, this Ordinance shall become effective on September 11, 2012.
