1 **A RESOLUTION** concerning

3 **Amendment to authorization to execute documents in connection with the**  
4 **“EPA Appropriations Act Fiscal 2003, Town of La Plata, Maryland” Grant**

6 **FOR** the purpose of amending the name of the person authorized to execute documents on  
7 behalf of the Town of La Plata (“the Town”) in connection with the “EPA  
8 Appropriations Act Fiscal 2003, Town of La Plata, Maryland” Grant; and all matters  
9 relating to said amendment.

13 **WHEREAS**, in connection with the “EPA Appropriations Act Fiscal 2003, Town of  
14 La Plata, Maryland” Grant issued by the Environmental Protection Agency and accepted by  
15 the Town, the Town was required to name the person authorized to execute and deliver on  
16 behalf of the Town documents related to said Grant; and

18 **WHEREAS**, on May 13, 2003, the Town Council adopted Resolution 03-4,  
19 identifying the Town’s Chief Executive Officer as the person so authorized, and  
20 subsequently identified Douglas R. Miller, Town Manager, as such authorized signatory; and

22 **WHEREAS**, following the departure of Douglas R. Miller as Town Manager of the  
23 Town, it became necessary to amend the name of the person so authorized, which was  
24 accomplished by adoption of Resolution 06-3 on April 11, 2006, naming Michelle D. Miner  
25 as the person appointed Town Manager and authorized to execute and deliver said Grant  
26 documents; and

28 **WHEREAS**, Michelle D. Miner is no longer the Town Manager of the Town, and it  
29 has again become necessary to amend the name of the person so authorized;

31           **NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE TOWN**  
 32 **OF LA PLATA** that Joseph W. Norris has been appointed Town Manager and is named as  
 33 the person authorized to execute documents on behalf of the Town in connection with the  
 34 “EPA Appropriations Act Fiscal 2003, Town of La Plata, Maryland” Grant.
