33 **Q. FEE IN LIEU OF ON-SITE STORMWATER MANAGEMENT:**

35 (1) AS PER THE REQUIREMENTS OF CHAPTER 167, § 167-4.4, OF THE TOWN
36 CODE OF ORDINANCES, THE FEE IN LIEU OF ON-SITE STORMWATER
37 MANAGEMENT IS ONE DOLLAR (\$1.) PER SQUARE FOOT AREA OF THE PORTION
38 OF THE SITE WITHIN THE LIMITS OF DISTURBANCE OF THE DEVELOPMENT, LESS
39 THE ACTUAL COST OF ANY ENVIRONMENTAL SITE DESIGN FEATURES
40 INSTALLED ON THE SITE.

41 (2) THIS FEE SHALL BE COLLECTED UPON THE ISSUANCE OF A GRADING
42 PERMIT.

46 **101-18. CREDIT AND DEBIT CARD TRANSACTION CONVENIENCE FEE.**

48 WHENEVER A CREDIT OR DEBIT CARD IS USED TO MAKE PAYMENT TO THE
49 TOWN FOR ANY FEES, INVOICES OR ANY OTHER CHARGES, TWO AND ONE HALF
50 PERCENT (2.5%) OF THE TRANSACTION TOTAL WILL BE COLLECTED AT THE TIME
51 OF TRANSACTION.
