5 **FOR** the purpose of correcting an omission by the publisher of the Town Code in the description of
6 the Election Ward Boundaries description of Ward IV; and matters generally relating to the
7 correction of the description of the Ward IV Election Ward Boundaries.

9 **BY** repealing and reenacting with amendments
10 Chapter 17 – Elections
11 Article III. Councilmanic Wards
12 Section 17-19A.(4)
13 Code of the Town of La Plata
14 (1998 Edition and Supplements)

16 **WHEREAS**, it has been discovered that the publisher of the Code omitted certain language in
17 the description of the boundaries of Ward IV, which should have been included when §17-19A was
18 amended by Ordinance 02-18.
19

20 **SECTION 1: BE IT ENACTED BY THE COUNCIL OF THE TOWN OF LA PLATA**
21 that Chapter 17, Section 17-19A.(4) of the Code of the Town of La Plata be repealed and reenacted
22 as follows:

Chapter 17 – Elections
Article III. Councilmanic Wards

26 **Section 17-19 Description of wards.**
27

28 A. The town is hereby divided into four (4) wards. The four (4) wards are described in
29 paragraphs (1) through (4) of this subsection and are graphically shown on a map maintained on file
30 in the office of the Town Clerk. In the event of a conflict between the description of a ward as set
31 forth below and as depicted on the map maintained on file in the office of the Town Clerk, the
32 description set forth below shall prevail. The Town's four wards are described as follows:

34 (4) Ward No. 4 generally consists of the southeast quadrant of the Town and is
35 described as follows:

36 Beginning at a point at the southeast corner of 1010 Charles street, the Ward
37 Four boundary line runs to the southwesterly corner of the Agricopia Subdivision; then continues
38 along the southern boundary of the Agricopia Subdivision to a point where it intersects with La Plata
39 Road (Route 488); then continues along the corporate limits at La Plata Road then along the
40 corporate limits at Charles Street and along the corporate limits at the Clarks Run Stream; THEN
41 ALONG THE CORPORATE LIMITS WHICH ENVELOPES THE CLARKS RUN
42 SUBDIVISION; then along the corporate limits WHERE IT ((which)) intersects with the CSX
43 Railroad right-of-way and includes lots 32 through 61 of Martin’s Crossing, which is the portion of
44 the parcel subject of the “McPhee Annexation” which is north of Glen Albin Road. The Ward Four
45 boundary then continues northward along the CSX railroad right-of-way to a point where it intersects
46 the southern right-of-way line of Charles Street, then continues eastward to a point where it intersects
47 with the westerly boundary of Ward Three at Willow Lane; then continues along the Ward Three
48 boundary to the southeast corner of 1010 Charles Street.

50 SECTION 2: AND BE IT FURTHER ENACTED, that this emergency ordinance shall
51 become effective on April 12, 2005.
