► Legislation

Mr. Mears discussed the Council work sessions and hearing related to the ordinances for consideration and discussed the amendments to ordinance 12-05, to amend the language related to the stormwater management fee.

Ordinance No. 12-04 Town of La Plata FY2012-2013 Financial Plan/Budget (for consideration of adoption) – For the purpose of adopting the Town of La Plata FY2012-2013 Financial Plan/Budget; and all matters generally relating thereto.

Councilman Winkler moved to adopt Ordinance No. 12-04 Town of La Plata FY2012-2013 Financial Plan/Budget. Councilman Norris seconded the motion. Motion carried by unanimous vote.

Ordinance No. 12-05 FY2012-2013 Fee Schedule (for consideration of adoption) – For the purpose of adopting the Fee Schedule, dealing with fees set by the Town of La Plata; and all matters generally relating thereto.

Amendments to Ordinance No. 12-05 **FY 2012-2013 Fee Schedule**

1. Line 718, immediately after (ERU), strike “, INCLUDING MULTI-FAMILY DWELLING UNITS AND TWELVE DOLLARS AND FIFTY CENTS (\$12.50) PER EQUIVALENT RESIDENTIAL UNIT (ERU) FOR COMMERCIAL UNITS,”.
2. Line 724, strike “THE EQUIVALENT RESIDENTIAL UNIT (ERU) IS CALCULATED PER AN AVERAGE AMOUNT OF IMPERVIOUS SURFACES ON EACH LOT FOR SINGLE-FAMILY RESIDENCES.”

Councilman Norris moved to adopt Amendments 1 and 2 to Ordinance No. 12-05 FY2012-2013 Fee Schedule. Councilwoman Mudd seconded the motion. Motion carried by unanimous vote.
